The Land Institute was co-founded in 1976 by Wes and Dana Jackson in Salina, Kansas. Wes is credited with first using the term “sustainable agriculture” in his book *New Roots for Agriculture*, published in 1980, and launching our journey toward perennial grains.

Today, The Land Institute leads the global movement for perennial, diverse, truly regenerative agriculture at a scale. Our work, led by a community of scientists and researchers in partnerships worldwide, focuses on developing perennial grains food crops, like cereals, pulses, and oilseeds, to be grown in ecologically intensified mixtures known as polycultures. The goal is to create an agriculture system that mimics natural systems to produce ample food and reduce or eliminate the disservices of modern agriculture. The Land Institute builds learning communities through transdisciplinary research and collaborations to help society cross the threshold into a perennial future for all.

Long-View

We engage art and philosophy to inform our scientific pursuits. We consider the entire ecosphere and then focus our intellect on real solutions created by people working with real plants in real places.

Courage

We are not intimidated by pursuing transformational solutions that don't fit into the current research or societal paradigm and for which success is not assured. We are committed to telling the truth, including about what we don't know yet. Our public service mission and financial independence help us maintain the flexibility and courage to do what is necessary but may not be popular or easy.
